Few of the other Boeing clubs meet this rule either mainly due to a lack of current employees willing to take on the job.

Budget: The 2019 budget was reviewed by the members present.

Membership: We had 51 members at the end of 2018. So far 22 have paid their dues for 2019.

Library Location: At the January business meeting the members voted to have the library downstairs instead of upstairs. We need to get the downstairs area cleared out to make room.

Website Update: Various members present expressed a desire for the website to be updated more often. In light of the cessation of the newsletter the it was proposed, discussed, moved, seconded and passed without opposition to email the meeting minutes and monthly schedule of events to all members.
